**City of Minneapolis -
Councilmember Lisa Goodman**

Working hard to get back to Lunch with Lisa and the field trip to Dayton's. Newsletter will give sign-up

information. Planning Robert Lillgren presentation. Board of Adjustment approved a variance for a garage at 420 Penn. The SW LRT required annual meeting to discuss safety issues during construction is set for Wednesday, September 30; it will be a virtual meeting. Continue to fill Boards and Committees (24 boards and 97 openings). Opening for Public Health Advisory. Dr. Paul Pentel has been serving in that position, Karen Soderberg before that. Was able to pass a ban on menthol cigarettes and raise age to buy cigarettes. Thanked him for his work. September is National Preparedness Month, for disaster related planning. Temporary \$300/week benefit for those unemployed due to CoVid. General election ballots will be mailed starting September 18 for no-excuse absentee voting. Also early voting locations provided in addition to voting in person on November 3. National Night Out has been moved to September 15. Restrictions in place for social distancing, masks, and sharing food. Neighborhood 2020 plan has extended public comments to September 30. Neighbors are receiving a postcard to give feedback during a 45-day review for the Built Form guidance in the 2040 plan, which describes height, setbacks, impervious surface etc. No changes for Interior 1 and Interior 2, which includes Bryn Mawr. Answered questions about the city council stance on the future of the police department and charter change. Hard to tell where this is going, no concrete plans. Have not formally reduced the number of police officers, but the force is less because of retirements and leaves of absence. We are in a period of unemployment, homelessness, and hopelessness, and there is a pattern of youth committing robbery and stealing cars. Charter change might come up next year. Need to determine what police officers should be doing, what kinds of calls should they be answering. Who else has a place in public safety? Getting recommendations from Michelle Gross, Communities Against Police Brutality. Need a culture change at the police department. City Council colleagues working on a community engagement process.

Crime Prevention Specialist - Rowena Holmes

There has been an uptick in crime in the city. There have been 57 mur-

ders to date; 48 in all of 2019. 4th Precinct working hard to deter criminal activity. Down several officers due to leaves, attrition, and retirements. Officers are showing up as quickly and as often as they can. Requested that officers drive Bryn Mawr streets and around the park during down time. Asks that we support the police department in any way we can. Two robberies at Cuppa Java this summer. Caught two suspects; they are in the juvenile justice center. Met earlier with neighbors about the homeless encampment in the Meadows which has been moved. Met with Adrian Lewis, Area 6, and a group of neighbors about forming a walking patrol. The non-confrontational presence of neighbors walking the streets and alleys makes lawbreakers uncomfortable. Adrian will work with Rowena to form a watch group; she has heard from about a dozen people who want to participate. Contact Adrian for more information 612-670-2587 alewis51@gmail.com. MPD will hold a Personal Safety Presentation for those who want to participate. There was some discussion about ensuring that our actions are positive and we continue to be a welcoming neighborhood. Safety tips-leave your lights on, park in your garage, walk the neighborhood and parks, use the park as much as possible. Encourage participation in National Night Out. Watch for vehicles without license plates and report to 911. Images captured by neighbors of license plates and faces is helpful to the police.

Downtown Bryn Mawr Security - Kevin Thompson

Have had crimes of opportunity in the past. Suspect in Market robbery is in Federal custody. Some items were stolen from Rolaynes in another incident. Need to be downtown more, continue to support and increase traffic at our businesses. Discussed cameras being used downtown. The Market is interested in security cameras that would capture a broader part of downtown; looking for funds from other businesses and their Go Fund Me dollars. Wondering about the possibility of using dollars from the BMNA safety allocation this spring or community projects funds. Questions about alternatives to calling 911 when it's not an emergency. The safety page on the bmna.org website has resources to contact other than 911. COPE is a Hennepin County mental health resource-612-596-1223. Discussed the fine line of being safe and vigilant and still being welcoming to those who don't live in the neighborhood.

Treasurer Report - JD Dietrich

Reports are online. \$13,340 in checking. \$118,000 in savings. Cleaning up small recurring expenses for services not used. Continue to work on PASS accounts. Have moved PayPal dollars into our account. Taxes are filed. Looking at a Village Bank 1% CD. Discussed

specific expenses and record keeping for garden committee.

Neighborhoods 2020 - Kevin Thompson

Comments on the plan are due by September 30. Kevin expressed a concern about the formula being proposed and a possible conflict with the group proposing changes benefitting financially from the formula change. He feels the base for all neighborhoods should be at least \$20,000. CPP is a large financial commitment from the city and they are facing budget challenges. The Racial Justice committee will review the recommendations at their September 17 meeting through the Issue Review Process lens. Kevin will re-send the final 2020 report and the response from a group of different neighborhoods.

Communications and Fundraising Report - Lynda Shaheen

Member Night on September 24 at Utepils has generated interest from neighbors wanting to know if they are members and have donated. Going to send emails to those who have given in the past and encourage them to come. Laura Glass has volunteered and redesigned our T-shirt. Communication has focused on voting, the census, crime reports. Archiving all our neighborhood communication email newsletters on our website which will help those wanting to go back to an issue and find the link to more information. Proposed that National Night Out be at the Meadows, encourage people to do a walking loop.

Event Report - McKenzie Erickson

Successful summer yoga series-14 to 22 people each time. Anti-Racist Bryn Mawr Workshop Series starting on September 28. Need 12 or more participants, virtual, facilitated by Rie Gilsdorf. Member Night coming up, participating in citywide Litter Be Gone, encouraging neighborhood clean-up. Working on getting racial justice books in the Free Little Libraries. Hopes for a Sip and Stroll and Saturnalia.

Bugle - JoEllyn Jolstad

The deadline for articles/ads is the 20th, as always. Sue has an article. Got press releases from neighborhood businesses. New tenant going into the corner store, hope to get advertising.



New COVID-19 Housing Assistance Program

Minnesota’s COVID-19 Housing Assistance Program has opened to cover housing expenses such as rent, mortgage, utilities or other housing-related costs. This program will help keep folks in their homes and maintain housing stability for eligible renters and homeowners in communities across the state.

People in Minnesota interested in applying for assistance can call the Greater Twin Cities United Way’s 211 Resource Helpline at 651-291-0211, visiting 211unitedway.org or texting “MNRENT” or “MNHOME” to 898-211. The 211 Helpline has dedicated multilingual staff to answer questions about the COVID-19 Housing Assistance Program 8 a.m.-8 p.m. Mondays through Fridays.

Census Deadline Extended

Due to the pandemic, the original census deadline was extended to October 31 but then was changed to September 30. Federal courts ruled to keep the modified timeline of October 31. Door knocking and follow-up efforts will continue through October 31. The census is important because it determines nearly \$1.5 trillion in federal resources for transportation, housing, schools, health insurance, social service and infrastructure. Minnesota receives nearly \$15 billion of that money. The census also determines political representation, the number of congressional seats allocated to Minnesota. It is important that everyone is counted!

Turn North to the Capri

Very soon, the renovated Capri Theater will be another reason to turn north and drive up Penn Avenue. In October, the \$12.5 million expansion and renovation of the Capri will be completed and be ready to welcome yet another wave of performing artists, aspiring students and enthusiastic audiences as COVID considerations allow.

For 93 years, the Capri has stood next to the junction of West Broadway and Penn as a significant feature of north Minneapolis artistry and culture. Prince performed his first solo concert on the Capri stage in 1979. Besides offering a stage for neighborhood talent, the Capri has welcomed audiences who thrilled to the performances of groups like Moore By Four and the St. Paul Chamber Orchestra. Dennis Spears, teacher and artistic director of the Capri’s Legends music series, is a performer familiar to many in the Twin Cities, especially in Bryn Mawr.

The Capri is part of the campus of PCYC (Plymouth Christian Youth Center), which also manages the Bright Futures K-5 enrichment program, and PYC Arts & Technology High School, a contract alternative school that provides students a

wealth of ways to earn credits toward graduation. As a renovated and expanded teaching facility, the Capri will be more than an entertainment anchor and attraction. With this expansion and renovation, the multi-faceted Capri is about to become a linchpin to north Minneapolis revitalization.

Watch for the reopening of the Capri, and plan to make the short trip up Penn Avenue. The Racial Justice committee of the Bryn Mawr Neighborhood Association will be promoting patronage of BIPOC business to the north, and a trip to the Capri will be a splendid way to become familiar with and be part of the revitalization of north Minneapolis. Besides the exciting performances on its stage, the Capri will offer the chance to make a pilgrimage to touch the very floorboards on which Prince made his debut in 1979.

BMNA Yearly COMMUNITY PROJECTS

The BMNA Community Projects Committee is looking for good ideas to improve Bryn Mawr. You could have the perfect suggestion.

Timeline:

Ideas will be solicited from now until December 31, 2020. The committee will meet in January 2021 to identify workable projects and present them to the board at their February 2021 board meeting.

The Process:

Request for proposals October - December 2020.
Submit proposals to jessica.wiley@bmna.org by December 31, 2020.

Those who have submitted an idea will be asked to complete a brief form about specifics of the project.

- Describe the project
- Who will lead the project?
- What will it involve?
- How much funding is needed?
- Who will benefit from the project?

The committee evaluates suggestions using the criteria listed below.

- Is there leadership (an identified neighbor) to get the project done?

- Is it possible (politically, physically)?
- Does it meet the budget (Up to \$6000)?
- Is it sustainable long term?
- Does it have neighborhood wide impact?

The BMNA Community Project program has been in place for the last 14 years. Each year we ask neighbors to suggest projects that improve livability and safety in Bryn Mawr. Projects from past years include:

- Utility box wrap on Cedar Lake Parkway and Ewing
- Doggy Waste Stations installed throughout the neighborhood
- Garden plantings at Anwatin/Bryn Mawr school sign
- Installation of an original Stacia Goodman mosaic in downtown Bryn Mawr
- Support for Minneapolis Nature Pre-School and Nature Play Adventure Camp for 4-7 year olds
- Traffic speed indication sign
- A bee hotel placed in J.D. Rivers Children's Garden
- Construction of a bench at Brownie Lake
- Buckthorn removal in Chestnut Park/Fruen Mill area over six years
- Construction of a Little Library on Penn Avenue
- 2011 Pedal to Pedal garden bike ride; which culminated in a renewal of our alternate year garden tour program
- Downtown banner project: Part of a joint City of Minneapolis/BMNA NRP project
- Ash Bore identification project: Our team identified more than 800 ash trees in Bryn Mawr and presented neighbors with a variety of options
- Energy Challenge. Over 80 neighbors joined the challenge and received statistics about their energy use. From this project we leveraged our

relationship with SEE to receive two cash awards that benefited BMNA initiatives

- Redesigning the Upton garden in Area 4. Our first community project; we completed a remake of the Upton garden and thanks to Cathy Skalicky, created a plan for ongoing maintenance. Drive by to enjoy the beauty

The Community Project Committee includes BMNA board members Steve Harvey, Area 7; Jay Peterson, Area 6; Joanne Michalec, Area 4; Jessica Wiley, Area 3; Susan Verrett, Area 2. and Neighborhood Coordinator, Lynda Shaheen. The committee also considers suggestions from past years. We just can't let go of a good idea!

Crime & Safety

Discussion of Crime in Bryn Mawr

Bryn Mawr has experienced some unsettling criminal activity recently which has put some neighbors on edge and left some wondering what can be done to stop/reverse the trend. Given this concern, I thought I would compare some data from this year and last to see if there is, in fact, a trend developing. I am including some graphics supplied by our Crime Prevention Specialist, Torie Stone. Crime is tracked by categories, such as Violent and Property. Violent involves actions against people while Property is directed at things. Violent crimes include homicide, rape, robbery, aggravated assault and domestic aggravated assault. Some crimes in the Violent category can be more serious than others in the outcome, such as the level of injury sustained by a victim of aggravated assault, which could be none to minor to major. This level of information is not included in the raw statistics. Also not included in the raw statistics is whether a reported crime (in any category) remained sustained as an actual crime through the investigatory phases. In other words, the raw data is reported crime without refining information. Year-end data could be revised downward if some of the reports end up not being sustained. You can see that in the raw data for 2019 versus the 2020 graphic. For the year 2019, there were 10 reported violent crimes in Bryn Mawr over the course of the year but year-end data was revised to 5 total.

For 2020, as of the time of this article's writing, there have been 8 reported violent crimes in Bryn

Mawr. This is about on pace with the reports for 2019. Some of these are known publicly, such as the armed robbery at the Bryn Mawr Market and the strong-arm robbery at Cuppa Java (strong-arm = physical force or numbers but no weapons). For property crime, the reported numbers for 2020 are not dramatically different from the reported numbers for 2019 so far. Property crimes can range from nuisance issues such as people going through mostly unlocked vehicles, people wandering through alleys checking for open service doors, etc., to residential burglaries. Low level nuisance crimes are ever-present and happen all over, not just in Bryn Mawr. Residential burglaries in Bryn Mawr fluctuate. When they come in spurts, often the perpetrator(s) are the same people hitting more than one home in the neighborhood and when caught, the outbreak stops.

Even with the recent robberies in downtown Bryn Mawr, it is important to note that the crime rate in Bryn Mawr is not high as compared to many other areas of Minneapolis (which is not to say these incidents aren't rightly alarming and traumatic). You can see comparison data in the Totals by Neighborhood section of the graphics. We are now and for decades have been one of the lowest crime areas of the city. The 4th Precinct has taken the recent crimes here seriously. The perpetrator of the robbery the Market was apprehended. He turned out to be a serial offender here and in other jurisdictions and is currently in federal custody. Two of the perpetrators of the robbery at Cuppa Java are reportedly in custody as well.

Little information has been given on them because they are juveniles.

To some degree, our heightened awareness of crime may exist due to the ability for people to share their experiences on social media. It's possible to read about crimes, big and small, very quickly now after they happen or even while they're in process on apps like NextDoor or Citizen.

The BMNA follows crime in the neighborhood and maintains regular contact with MPD and our MPD Crime Prevention Specialists on issues of concern, such as when we had a rash of burglaries a few years ago. In that instance communication with MPD and the Crime Prevention office was frequent until the perpetrators were apprehended. Turned out to be 2 juveniles riding bikes around and checking on doors where they thought no one would be home. The BMNA puts out alerts on such trends, works to get the attention of the appropriate agencies and follows them through to resolution.

The BMNA is not intended to be a crime fighting organization, but rather a community building one. The biggest aim of the Association is to increase connections between neighbors and to foster a feeling of comfort in the neighborhood and the notion of neighbors looking out for each other in a positive way. Comfortable, safe neighborhoods have people who take walks, walk pets, sit on front porches, use local businesses, go to local parks, get to know and have awareness of their neighbors, and so on. Activity such as this is a natural deterrent to crimes of opportunity since there are many "eyes on the streets" routinely as well as eyes on each other's homes when neighbors are known to be away, but in a comfortable and comforting manner.

2020 has brought with it some tremendous challenges, including

George Floyd's death which touched off worldwide protests and much unrest in Minneapolis itself. Bryn Mawr is not immune to the effects of things happening around the city even though the neighborhood largely escaped the brunt of the unrest. On top of that, COVID-19 has taken people's lives and livelihoods and increased desperation and need among many. Some of the general uptick in Minneapolis crime may be attributed to the economic desperation associated with the pandemic.

Challenges can be opportunities for growth. Giving can be rewarding. Compassion and empathy can enlarge the human heart. Looking at problems through new or different lenses can be helpful. One thing the BMNA has done is to establish a Racial Justice Committee through which to explore and better understand racial inequities and how our neighborhood can participate in making things better going forward, and to consider ways the neighborhood can be aware of issues such as crime while also being open and welcoming.

Take reasonable precautions such as locking vehicle doors, garage doors, adding lighting, installing technology, keeping the front door locked when in the back yard, and so forth. Some neighbors are looking into training with the MPD Crime Prevention Office of the 4th Precinct on crime prevention strategies to implement on their blocks and the neighborhood.

In addition to precautions and awareness, please also continue the spirit of caring for and getting to know neighbors that has made Bryn Mawr a desirable place to live for so many years. Walk, rock on the porch, visit the parks, play, recreate, support local businesses as they weather this difficult era, greet and welcome each other.

Public hearing on Southwest Parks Plan scheduled October 7

The Minneapolis Park and Recreation Board (MPRB) will hold a public hearing on the Southwest Service Area Master Plan on Wednesday, Oct. 7, 2020 at 6:45 pm during the regular meeting.

The Southwest Service Area Master Plan includes long-term plans for 42 neighborhood parks, one regional feature, six potential parks, and four park search areas in Southwest Minneapolis. It sets a vision for the improvement, operation and management of all neighborhood parks in Southwest Minneapolis over the next 20-30 years. The plan was created after nearly two years of community-based engagement, planning and design with individuals, neighborhood groups and community organizations throughout Southwest Minneapolis.

The MPRB is adhering to social distancing recommendations during the COVID-19 pandemic and all Board meetings are being held virtually. The public is encouraged to view the meeting from home and email comments on the plan to jringold@minneapolisparks.org before 3:30 pm on Oct. 7. Comments should be limited to approximately 300 words, which is similar to three minutes when they are read out loud by the Secretary at the Board meeting.

After the hearing, the Planning Committee will consider approval of the Southwest Parks Plan. The full board could consider final approval at either its Oct. 21 or Nov. 4 meeting.


