Agenda approval moved by Colleen, seconded by Barry. Motion carried.

Minutes from September moved by Jay, seconded Rod. Motion carried.

**City of Minneapolis - Councilmember Lisa Goodman**

Lisa encourages everyone to get her newsletter; sign up at judy.sherin@minneapolismn.gov  
Lunch with Lisa will be online October 28. Metropolitan Councilmember Robert Lilligren will be the guest. Dayton’s hourlong tour will also be online in November. Public works sewer project starting. First phase will be 18 months along Irving Ave No. Second phase will run through the Bryn Mawr Meadows to Laurel and Morgan. There will be noise and vibrations. Variance requests approved on Laurel. Street sweeping starts October 20. The census is complete. 5.75% increase in Mayor’s budget, will result in a reduction in property taxes.

**Crime Prevention Specialist – Rowena Holmes**

To date, there have been only two incidents in the 4th Precinct in October; an assault that took place in Bryn Mawr and a car theft in Harrison. A group forming a citizens’ patrol will be meeting with Rowena for training on October 19 at La Mesa at 6:00PM.

**Treasurer Report – JD Dietrich**

Written report submitted.  
\$118,004.97 in savings, \$12,845.84 in checking, \$369.24 Paypal transfers.

**Wirth on the Woods pond/runoff remediation planning update - Rod Miller/McKenzie Erickson**

Rod reviewed the project. There are water table issues. Will be draining the water away to a retention pond. It is not considered a landscaping

feature. Rod has been in contact with the Upton neighbors; the plans have been sent to them. There is acceptance of the plan by the stakeholders. Will be using the least intrusive fencing. The main ski trail that runs behind the property will be maintained.

**Communications and Fundraising Report - Lynda Shaheen**

Member night on Utepils’ outdoor patio was a success. About 60 people attended; we generated more revenue than last year. More spirit wear was sold. Membership donations are spot on with last year. Barry has taken over putting our welcome packets together.

**Event Report – McKenzie Erickson**

Generated \$2200 at Member night from membership donations, spirit wear, and plant sale. Litter Be Gone, on October 10 had 31 participants. Anti-racist workshop has 20 signed up; have had three sessions so far. Brought in \$800 in registrations. Sip and Stroll is set for October 22 from 5-8 PM. No one will be serving alcohol. Will have two hubs with live music at La Mesa and the Market. Stroll will take place between hubs. Have several donations from our businesses for the raffle. Sharing CDC information on having a CoVid safe Halloween.

**Bugle - JoEllyn Jolstad**

The deadline for articles/ads is the 20th, as usual. Great articles submitted for October Bugle; jam-packed. Jim Kalitowski has had a full-page ad in the Bugle for 25 years; is ending that advertising.

**Webmaster – Jeremy Stafford**

Quiet month. Registration for workshop required some problem solving. Working on a process for approving invoices, etc.

**Elections – Brian Treece**

President, Secretary, and 2, 4, and 6 are all up for re-election and we are accepting additional nominations. Will be using Google forms for voting if we have any contested seats. We moved the Annual Meeting from November 11 to November 18 to avoid Veteran’s Day. Have additional reps interested in Areas 1, 3, and 7. Will approve at our December business meeting.

Thanked Lynda and McKenzie for their help with the plant sale. \$645 raised which covered our expenses for the downtown summer planting. Planning fall clean up.

Used the Issue Review Process to craft our response to the Neighborhood 2020 proposal. Worked well to talk through issues. Books are purchased for the Little Libraries and the workshops are in progress.

No longer hold the insurance for the speed sign. Have 20 Is Plenty signs ready at Sip and Stroll.

**Schools – Lynda Shaheen**

Profiles of school board candidates in Bugle. Bryn Mawr Elementary School principal is looking for a community member to sit on their Leadership Site Team. They meet once a month.

**Other Standing Reports**

**ROC/Bassett Creek Valley- Colleen Belmont**

Sent a written report from October meeting. Update on Wellington property on 2nd Ave North. Property is 60-65% rented. Not enough pressure from the office market to build the office space on 2nd Avenue. Art Space project should be done by next summer, with move-ins in May. Fair Housing has said that anyone can apply. Marketing in North Minneapolis, but there is interest from the wider metro/suburbs. Eller Property would be 155 units, encouraged to build more 3-bedroom units in other projects to accommodate larger families. No street level retail is being planned due to zoning. Blue Line extension: No change, and CMC voted to explore other options. Train is more likely to go through West Broadway rather than along Hwy 55. Glenwood Ave bridge project is currently 1 year behind because of frequent stoppage for rail traffic.

**SWLRT – Barry Shade**

Might see construction on the Bryn Mawr station this fall.

## Area 4 - Support of At-Risk Youth

This time of year the Presbyterian Church has a special emphasis on Peacemaking culminating in the Peace and Global Witness Offering (<https://specialofferings.pcusa.org/offering/peace-global-witness/>). This special offer-

ing encourages congregations to cast off anxiety and fear, discord and division, and embrace our God's mission of reconciliation to those around the corner and around the world. Bryn Mawr Presbyterian Church takes a collection each year to help Presbyterian peacemaking efforts around the globe and a portion of that stays in our community to help peacemaking activities. This year the mission committee has selected Juxtaposition Arts. Juxtaposition Arts is a non-profit youth art and design education center, gallery, retail shop, and artists' studio space in North Minneapolis. They are more than an arts organization. They are directly involved in making an impact on the Northside both as a business standing firm on the Northside and by working directly with youth and their families to have an impact on their future. They have summer camps, ongoing visual arts programs for teens, employment programs that employ teens in high paying jobs in the arts right in the studios at JXTA, and college and career exploration programs. They provide meaningful safe activities for youth every day and for a sustainable future. Their mission states, "Juxtaposition Arts develops community by engaging and employing young urban artists in hands-on education initiatives that create pathways to self-sufficiency while actualizing creative power." Their work has been recognized and funded by the City of Minneapolis Violence Prevention Fund. More can be learned at <https://juxtapositionarts.org>. This summer and fall have been particularly violent for young teens in North Minneapolis, several of whom attended our neighborhood schools. Help us contribute to non-violent opportunities for youth in our community and beyond.

## Have you noticed something happening to a building in south Bryn Mawr?

Demolition began a few months ago within the building previously called Crossroads, located on S. Wayzata Blvd. and Washburn Av. S. It dates back to the early 1960's when built as a new motel called The Voyager, a first in Bryn Mawr. Years later it closed as a motel and was purchased by the Crossroads organization as housing for those in addiction recovery programs. Those residents over the years contributed many hours to our Bryn Mawr neighborhood by helping at our ice cream socials and garage sales as well as removing trash along Wayzata Blvd. roadways. We will miss those folks because Crossroads sold the building this past winter and moved their business to St. Paul, where their mission no longer includes a residency concept. A

local developer has purchased the building and interior demolition began several months ago. The reconfiguration will be for 25 studio apartments of 400-500 square feet called The Bryn. There is already adequate underground parking as well as a surface lot to accommodate the future residents' cars. According to one of the construction workers I spoke with, the plans include a fitness center and coffee shop. Work will continue for several more months with a completion date hopefully by early winter. As of the date of this printing, I could find no information about whether any of these units will be classified as "affordable housing".

A follow up will be forthcoming when more is known.

# From the Editor

This week, a young person who was really important to me and my family died by suicide. This heartbreaking loss consumes my every waking moment the way planning safe trips to the store for groceries and toilet paper used to. While this tragedy could have taken place at any time, it didn't. It happened during a pandemic and an unprecedented time in the political history of our country.

This heroic college student had many of her own challenges and had also taken on her shoulders the weight of the election, the balance of the Supreme Court, the changing climate of the planet and our country's long history of oppressing women, BIMPOC and LGBTQ peoples. There is no way for me to know what the tipping point for her was, but certainly it could not have helped that she couldn't just go out for coffee or a meal in a restaurant with a friend and talk for hours, have her hand held and get endless hugs of support. So while she did not contract the actual Coronavirus, there is no doubt in my mind that it is what ultimately killed her.

It is hard to accept all the loss of life, lifestyle and commerce that this year has brought. Many restaurants, small independent theatres and countless other businesses have per-

manently closed. The Southwest Journal and City Pages newspapers have announced that they will stop publishing. They both cited the same reason for their folding. Fewer thriving businesses means diminished advertising revenue to sustain their staff and operating costs.

Saturnalia is an event meant to showcase our local businesses. It was scheduled to be outdoors but rain/snow and cold meant the bands couldn't play and with ducking into businesses not a safe alternative for the usual throng that attends, the event was cancelled.

The *Bugle* is still plugging along. It would seem that our advertisers see the value in supporting our work and our readers are supporting them in return. However, things still change for other reasons. For the past 25 years, Realtor Jim Kalitowski's full-page ads have graced page 3 of the *Bugle*. A week ago, he let me know that he was discontinuing his print ads. Jim He sold us both of our Bryn Mawr homes and his absence from these pages feels like the end of an era. He assured me he was still active in real estate, so I want to remind anyone looking to hire him, that his warm and funny ads will live on in the *Bugle* archives on [BMNA.org](http://BMNA.org).

## Crime Prevention Strategy

The City of Minneapolis is piloting a new initiative to decrease violence with “violence interrupters” on the streets in neighborhoods now. Outreach workers for the Minneapolis Strategic Outreach Initiative de-escalate situations before they become violent, support behavior change for people at the highest risk for violence and help communities heal. By identifying and interrupting conflicts and working to promote community healing, the initiative is intended to break the “contagious” aspects of violence such as retaliation.

The interrupters wear bright orange “Minneapolis” T-shirts highlighting the initiative’s purpose: to address the root causes of violence together as a community. The Minneapolis Health Department’s Office of Violence Prevention initiative complements existing outreach organizations’ work already on Minneapolis’ streets, employing a specific approach built on the idea that violence is a public health issue. This approach is rooted in the

power of Minneapolis communities. At the same time, it draws from strategies like Cure Violence, which has been effectively implemented across the globe.

**How does it work?**

Using informal mediation, non-physical conflict resolution and interruption expertise, trusted community members will work on our streets to stop conflicts before they happen and as they happen. They’ll also work to foster healing and mobilize communities to reject violence through strategies like awareness building, community gatherings and peace walks.

These trusted community members on neighborhood-specific teams have themselves experienced violence or are familiar with the impacts violence has on communities. They have strong relationships with young adults, neighborhood members, community leaders and service providers.

They will also work to connect people to jobs, housing, mental health and chemical dependency services, and other resources and supports.

## How Energy Efficient Is Your Neighborhood?

In January, the City of Minneapolis launched a one-of-a-kind energy disclosure for homes being sold in the city. Energy efficiency has consistently been a part of the conversation for people buying and selling homes and this policy allows people to see how efficiently homes use energy.

The map is growing of homes that have received an energy score. You can view the scores in your neighborhood by visiting [mncee.org/tish/yourscore](http://mncee.org/tish/yourscore).

The City of Minneapolis provides resources for people to make cost-

effective energy improvements on their homes:

- Up to \$1,000 in cash-back rebates
- Up to \$500 in energy tax credits
- 0% interest loans for the upfront cost

To make this all possible, the City Minneapolis and CenterPoint Energy have partnered with local nonprofit, Center for Energy and Environment, to provide an Energy Advisor service to assist homeowners with energy upgrades.

## Charter Amendments on the Ballot

November 3 is Election Day! Our polling place is Bryn Mawr Elementary School, 252 Upton Ave S. The polls will be open from 7am to 8pm. We will be voting for President and Vice President, U.S. Senator, U.S. Representative, State Senator, State Representative, School Board Members, and many judges. In addition there are two city questions on the ballot.

1.Shall the Minneapolis City Charter be amended to allow ward and park district boundaries to be reestablished in a year ending in 1 and to allow the use of those new boundaries for elections in that same year; to allow ward and park district boundaries to be modified after the legislature has been redistricted to establish City precinct boundaries; to provide that an election for a Council Member office required by Minnesota law in a year end-



ing in 2 or 3 after a redistricting shall be for a single 2-year term; and to clarify that a regular election means a regular general election?

2. Shall the Minneapolis City Charter be amended to comply with Minnesota election law related to uniform dates for special municipal elections and to provide that a special election be held on a legal election day under Minnesota law that is more than 90 days from a vacancy in the office of Mayor or Council Member?

## Board Adopts Issue Review Process (IRP)

In support of their goal to bring an equity lens to BMNA Board decisions, the Racial Justice Committee reviewed the current process for supporting initiatives and positions brought before the BMNA Board. The goal was to create a process that considers racial equity when the Board evaluates, develops, and implement policies, initiatives, programs, and budgets.

The Issue Review Process (IRP) was approved by the Board at their September 2020 meeting. A form of this process has been used successfully by the BMNA School Committee for the past 12 years.

It is not anticipated that using this process will significantly change the way the BMNA Board hears from neighbors, developers, other neighborhood associations, city and park employees, or elected officials. Currently, when someone wants to gain the Board's support by garnering a statement or letter, they contact the President or another Board member to explain their proposal, or they come to a Board meeting to be heard. This will continue.

The change will be in the information the Board gathers to better understand the issue and the adoption of an equity lens. The questions on the IRP request are meant to ensure that the policies and practices of the BMNA consider those who may be underrepresented in decisions that affect them.

### BMNA Issue Review Process (IRP)

Those requesting support or action from the Bryn Mawr Neighborhood Association for an issue of concern are asked to consider the questions posed on our Issue Review Process Request (IRPR) form. Responding to the IRPR will help BMNA committee and board members understand all the aspects of the request before hearing it at a committee or board meeting.

**Step 1:** Complete an Issue Review Process Request (IRPR) form.

**Step 2:** Submit the Issue Review Process Request (IRPR) form prior to meeting with the appropriate committee or board member, if possible, or be ready to share responses at a committee or Board meeting. (See [www.bmna.org](http://www.bmna.org) for contacts)

**Step 3:** Be available to discuss the request with the committee or board member.

# Working to End Family Violence in the Time of CoVid: Domestic Abuse Project (DAP)

Domestic violence advocates expressed concern about a potential increase in intimate partner violence when CoVid-19 cases surged in March 2020. Stay-at-home orders were put in place, schools closed, workers were furloughed, laid off, or told to work from home. With personal movement limited and people confined to their homes, actions intended to protect the public and prevent widespread infection left many domestic violence victims trapped with their abusers. Though many restrictions on movement have been lifted, the pandemic and its effects rage on, exposing a critical reality. According to the New England Journal of Medicine, "this pandemic has reinforced important truths: inequities related to social determinants of health are magnified during a crisis and sheltering in place does not inflict equivalent

hardship on all people." Those experiencing domestic strife and violence have been hard hit. "There was every reason to believe that the restrictions imposed to keep the virus from spreading would have such an effect, said Marianne Hester, a Bristol University sociologist who studies abusive relationships. Domestic violence goes up whenever families spend more time together, such as the Christmas and summer vacations, she said in the New York Times. Lele — her full name is not being used for her safety — told the New York Times that her husband had abused her throughout their six-year relationship, but that the CoVid-19 outbreak made things far worse. "During the epidemic, we were unable to go outside, and our conflicts just grew bigger and bigger and more and more frequent," she said. "Everything was exposed." We are fortunate in Minneapolis to have DAP in our city. DAP continues to support clients during CoVid.

At DAP, therapists and advocates work with families to end the cycle of abuse. They seek to permanently break the inter-generational cycle of family violence by providing men, women and children with essential tools needed to eliminate violence in their lives.

DAP advocacy supports victims as they navigate the legal system and connects them to resources a victim often needs in their moments of crisis.

DAP therapy is for men, women and children who are at a place in their lives when they can make real changes in their behaviors. "When my mom came here [DAP], she was sad. Thank you for helping her. I love my mom." -Hannah, age 5.

In 1979, DAP was the first organization in MN to offer a therapy program for men who use abuse in their intimate relationships. Since then, DAP has worked to not only heal but to prevent – as their work with children is truly preventative. Without intervention, children who witness domestic violence are 64% more likely to grow up to be abusers or victims.

DAP has a budget of roughly \$1.9 million dollars, which funds programs and services such as:

The Men's Program – using trauma informed therapy to teach men about the cycle of domestic violence and how to stop their use of abuse.

The Women and Children's program – supporting women and children birth to 18 on their journey of healing from the traumatic effects of abuse.

Providing crisis intervention services for families who are trying to escape the abuse present in their lives and/or navigate the criminal justice system as an abuse victim.

### Irving Ave N Sanitary Sewer Replacement

#### PROJECT BACKGROUND

Irving Ave N is a sanitary sewer replacement project along Irving Ave N from Currie Ave W through Bryn Mawr Meadows park to Laurel Ave W and Morgan Ave S. The City will replace 2010 feet of sanitary sewer in two phases starting fall of 2020. This will improve sanitary flow and reduce groundwater infiltration into the sewer. The original part of the sewer was built along Irving Ave N in 1905. Over the years, poor soils have caused the sewer to settle leading us to reconstruct portions of it. The new sanitary sewer will be constructed on a deeper foundation of piling to reduce future maintenance due to settlement.

- Phase 1** construction will be along Irving Ave N.
- Phase 2** construction will be along Bryn Mawr Meadows park to Laurel Ave W and Morgan Ave.

#### WHAT TO EXPECT

- Irving Ave N between Currie Ave and Bassett Creek will be closed. Access to local business will remain.
- The Luce Line Bike Trail in Bryn Mawr Meadows will be detoured for a portion of the project.
- There will be noise and vibration caused by the need for the sewer to have stronger support. We will be using piling, which is a type of structural support.

# Retention Pond Plans for Development at 2800 Wayzata Boulevard

Wirth on the Woods is a collaboration between Lupe Development and Swervo Development Corporation to build 99 units of affordable senior housing in a six-story building (The Theodore) and 100 units of market-rate senior housing (The Eloise) in another six-story building. These properties will share amenities, including an outdoor courtyard, garden and greenhouse. The campus, at 2800 Wayzata Blvd, will also include a renovated CenturyLink building.

Last spring, the BMNA was asked to give input about the landscaping and appearance of the site, and also to facilitate interaction with neighbors. There are water table issues on the property. A retaining pond, to be built at the existing entrance to the woods at the west end of the

Anwatin athletic field, will address water management problems that also cause water in basements for Upton Avenue neighbors. Board member Rod Miller and BMNA staff member McKenzie Erickson attended a virtual meeting last week to review the plan.

While the pond is not considered a landscaping feature, Lupe Development has made efforts to use native prairie plantings, benches, lighting on a walking path into Wirth Woods, and the least obtrusive fencing possible needed to secure the pond. The pond is being built on land shared with Minneapolis Public Schools and in consultation with the Minneapolis Parks and Recreation Board. Rod Miller continues to inform and get feedback from Upton Avenue property owners who are most impacted by the development.

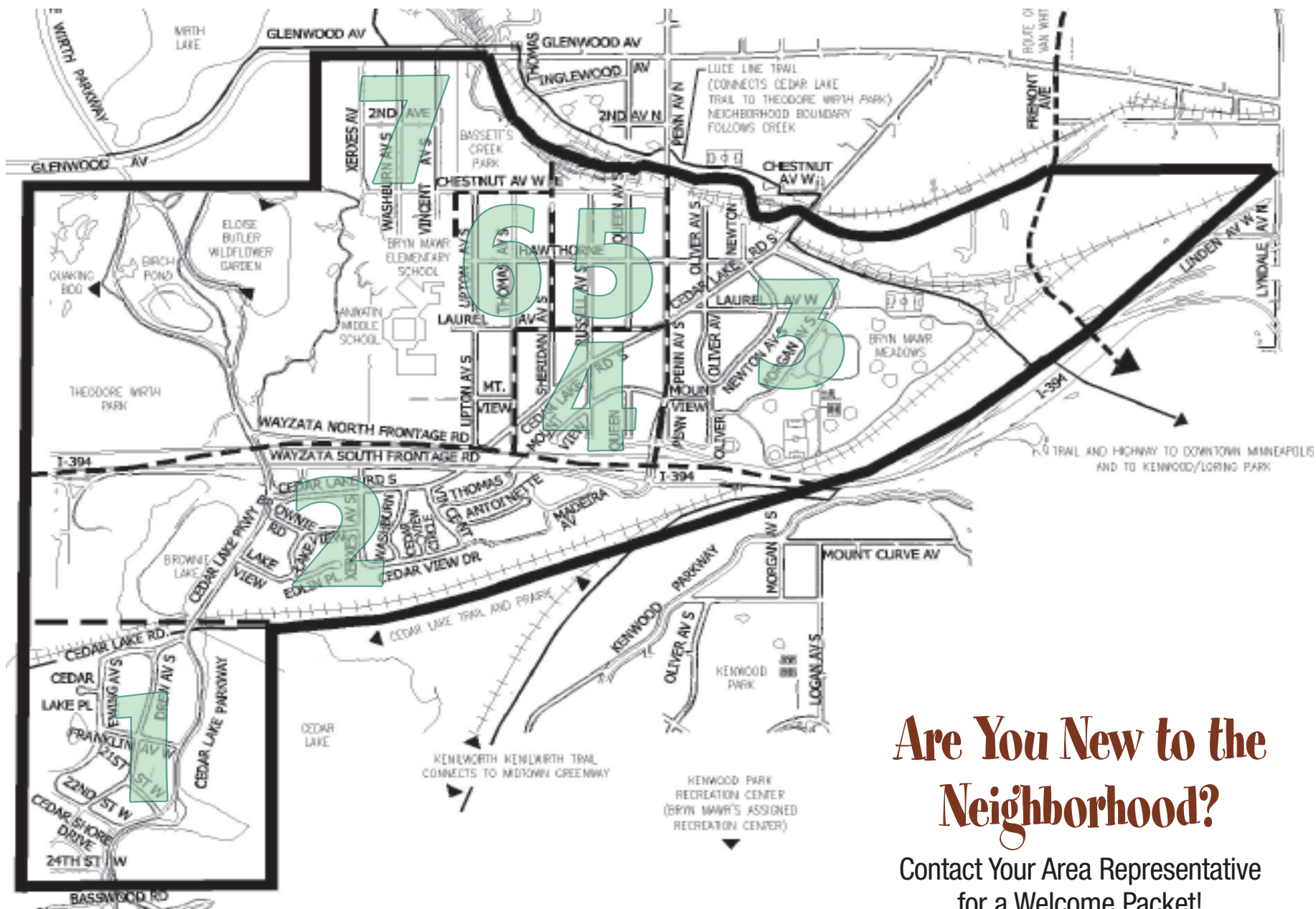
